Annette's Journey

Annette Suni Davis-Preston was born in Brooklyn, NY to the late James and Janie Chambers on October 18, 1960. Annette graduated from Eli Whitney Vocational High School in June 1978. Later in her life, she met and married, Amos Basheek Preston "Herc".

Annette accomplished many things in her life. She was a Certified Child Care Provider for many years and she and her husband "Herc" helped to raise three foster children. Annette truly loved children and wanted them in her life. Also, Annette regularly worked for the Election Voting Poles. She loved to network and she was like a database of knowledge. Annette traveled to the Bahamas in the early 90's and was involved with the Women's Leadership Worship Committee to advocate for the rights of women with HIV. She liked to share her personal life story to give others faith and hope. Annette would find many different avenues to reach out to people. For example, she would go to different public schools and other organizations to inform young people about the dangers of not practicing safe sex. Annette always had a patient ear to listen to others and she wanted to make a difference. She felt that if she touched one person's life, she gained a new friend.

Narcotics Anonymous was a big part of her life. She would recite the serenity prayer and share the twelve steps to sobriety with others who had no insight. She was patient and kind to those she sponsored in her eighteen years of affiliation with Narcotics Anonymous. She sponsored and led New Members through the Recovery Process. In addition, Annette volunteered for many years to help doctors discover new effective vaccinations for the cure of HIV.

Annette Suni Davis-Preston succumbed to her illness on September 15, 2010. She will always and forever be remembered for her work as an advocate for the rights of HIV patients.

She leaves to cherish her memories: her loving husband, Amos Basheek Preston; their adoptive daughter, Zaire; one grandson; two brothers, Everette Faber and James S. Chambers, Jr.; three sisters, Irma Harley, Deborah Johnson-Holton and Cheryl Lynn Donaldson; one sister-in-law, Francine Faber; one brother-in-law, Anthony Holton; four aunts, Mayphene Carr, Jesse Woods, Floria Bennett (who resides in Miami, FL) and Victoria Robinson (who resides in Charleston, SC); and a host of nieces, nephews, other relatives and friends.
