Oh, yes these things I too will miss.*

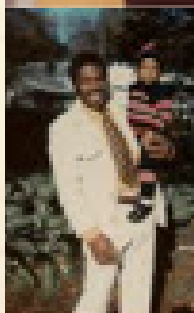
*Be not burdened with times of sorrow,

God wanted me now, He set me free!*

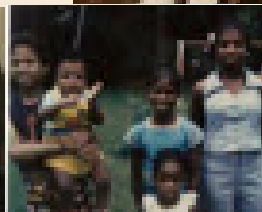
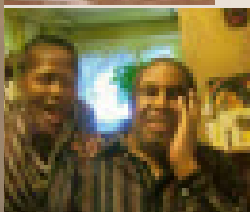
