Obituary

Edward Anthony Smith, Jr., whom we all know as “Tony” the third child and only son born to Edward and Katherine Smith, passed away on July 4, 2012 with his dear sister, Robin Rene, near his bedside at St. Luke’s Roosevelt Hospital in New York.

Tony was born on July 16, 1957 at Mt. Sinai Hospital in NYC, New York. He attended and graduated from Brooklyn Technical High School. Upon graduating from high school, he started his career as a messenger. He, eventually, took the examination with NYC Transit Authority and passed with a very high score upon which he was steadily employed with the NYC Transit Authority until his retirement.

Tony raised his two nephews to their young adulthood age, Troy who lived with him when he was nine years old and, some years later, Craig whom he adopted at the age of eight. Tony did a wonderful job raising his nephews, always maintained a close relationship with his sister and usually, provided the family’s Thanksgiving Dinner in his apartment in the Bronx.

On September 6, 1998, Tony became an active member of SGI-USA, a lay Buddhist organization dedicated to the establishment of culture, peace and education through individual happiness, and, in a short time, accepted responsibilities as a Men’s Division District Leader in the Bronx. His apartment became one of the many meeting places in the Bronx for SGI activities.

Although faced with many obstacles with his health, it was during his Buddhist practice that he retired from the NYC Transit Authority and was able to fulfill all of his dreams. We all know that Tony loved to cook and was great at that. He attended The Natural Gourmet Cookery School of The Natural Gourmet Institute - a vegetarian culinary institute and graduated as “Chef Edward”. Shortly, afterward, he became Chef at Raw Foods in Harlem. He, also, was able to purchase a beautiful, new Co-op apartment in the Bronx where he continued to host SGI-USA activities.

Tony will be forever remembered for his loving kindness by his sisters, Stephanie, Robin Rene and Leslie; his nephews, Troy and Craig; his niece, Myra; his great niece, Tia; two great nephews, Troy and Elijah; his aunt, Sylvia; his aunt, Ruth; along with a host of cousins and devoted friends, especially Kevin, Ivan and Cy and associates.


