## The Obituary

**Cabronica Veattress Gordon,** formerly of Orange, New Jersey, was born at Orange Memorial Hospital, Orange, NJ on Sunday, July 26, 1914 to James Andrew Jackson and Noley Rose.

Cabronica was educated at Colgate Vocational School. She and her family were life-long members of Union Baptist Church of Orange, NJ where her father was a trustee and her mother was a faithful member under Rev. James H. Hughes, Pastor. She later moved to Quoque, Long Island, NY to live with her brother, Edward and his family and attended West Hampton Beach High School from which she graduated. Many years later she moved to New York City, NY and shared an apartment with her sister, Geraldine and began employment as a sales clerk. When that company closed, she returned to New Jersey where she met and was later united in marriage to James Russell Gordon of East Orange, NJ.

Two children, Barbara Kay Gordon and Barry Gordon, were born to this union. Several years later, when her children were in grammar school, she became a Girl Scout leader for Troop 121 at the Settlement House in West Orange, NJ. She also sold Avon products and Fashion Frocks. She left Union Baptist Church of Orange, NJ once she married and joined Calvary Baptist Church, East Orange, NJ to worship with her husband, who was already a member. After many years of faithful attendance, he was asked to become a Deacon. He agreed and as a result, she became a Deaconess. She was also a member of The Gospel Chorus and The Silver Leaf Club. Cabronica later renewed her membership at Union Baptist Church in Orange, NJ under the leadership of Rev. William McKinley Freeman.

She leaves to mourn her passing: her daughter, Barbara Kay Ellington Crawford of South Carolina; her son, James Barry Gordon of Louisiana. She was the grandmother of Judith Gault, Darlene D.
