Obituary

Kim Arturo Cohen, affectionately known as "Cee" passed away on November 8, 2017.

Cee was born on August 2, 1952 at Flowers Fifth Avenue Hospital in New York City to Gretchen Cohen. He was a long-time resident of the Bronx. In 1969, Cee graduated from New York High School of Printing.

Cee served in the U.S. Army from 1969 - 1972 in the capacity of a Marksman and as a Communication Specialist. In 1972, Cee received an honorable discharge. That same year, Cee began working for the Veterans Affairs Medical Center. For the next 33 years he worked in the capacity as an Orthotist wherein he designed, fabricated and modified orthotics and prosthetics. During that time period, he conducted weekly training and pre-clinical lectures. He handled fittings and evaluation of orthotics and prosthetics for patients. He also trained interns and journeymen in the orthotics and prosthetics service. In 2004, Cee retired from the Veterans Affairs Medical Center. To keep active after retiring, he worked security for various nursing homes and independently sold vitamins. Cee also enjoyed learning new things and received certificates in many fields.

In 1998, he made a friend in Shirley Williams, who would later become his soul mate. In 2001, as they began their relationship, she became the love of his life. On December 12, 2012, they were joined in matrimony.

After a lengthy stay at Schervier Nursing Care Center and a short stay at Montefiore Hospital, Cee was called home on November 8, 2017. He is survived by his long-time soul mate and wife of five years. He leaves to mourn and cherish his memory: his loving wife, Shirley Williams-Cohen; three step-children, Maurice Woodard, Ebony Woodard, and Milton Woodard II; three grandchildren, Yanira Woodard, Amya Woodard, and Kameron Carr; one brother, Christopher Romaine; three brothers-in-law, Larry Williams (Robin), Robert Williams, and Charlie Williams (Patricia); one sister-in-law, Paula Williams; as well as a host of other family members and friends.
