<u>Obituary</u>

Joseph Curtis Moses was born on April 27, 1946 in Harlem, New York. He was the middle child of the late Jessie Mae Gilliam.

Joseph grew up in East Harlem with his mother, older brother Henry and younger sister Yvette. During his formative years, he was known as "Cookie." He attended the local area schools. During those years, Joseph grew to love music. In particularly, the Motown sound. Because of his love for music, he was a frequent visitor to the Apollo Theater. While at the Apollo, he would meet and become friends with many of the performers who came there. As a result, he created the alter ego, "Chuck Scott".

Chuck Scott as he was commonly known, was a sharp dresser and the life of the party. He began his party days at the Shalimar Night Club in Harlem in the late 60's. Years later he continued to enjoy attending the Felix Hernandez dances at Roseland.

In between attending dances, he became a DJ and Master of Ceremonies at many local parties that were held throughout the city. Because of this, he coined himself "World Famous".

He also held regular jobs through the years. The jobs ranged from middle management level positions to his final position at Columbia University. At Columbia University he was a Building Custodian for 19 years.

On his birthday in 2002, Joseph married Katrina Smalls and moved to Brooklyn. While moving to Brooklyn was new to him, he learned to embrace living there. He and Katrina began traveling around the world. He enjoyed going to places like Hawaii, Brazil and the Bahamas.

In addition to traveling and going to parties, he enjoyed spending time with his daughter Michellina. In his younger years, Joseph would walk with her around Harlem showing her all of the food eateries and places where he grew up. He was also the father to Michael, with whom he would fondly trade stories with of their life experiences.

Since 2017, Joseph's health had been on the decline. He was in various nursing homes and hospitals with a host of different illnesses. During those stays, a host of family members and friends would call and visit him to offer support and to cheer him up.

He fought a good fight until the end. And now he will be at peace with his mother and brother whom he missed dearly.

He is survived by: his wife, Katrina; daughter, Michellina Hunter; son, Michael Saunders; sister, Yvette Gilliam (Mike); sister-in-law, Denise Clayton; stepdaughter, Tiffany Smalls; stepson, Eugene Smalls; grandson, Gavin Norman; nieces and nephews; along with a host of friends.
