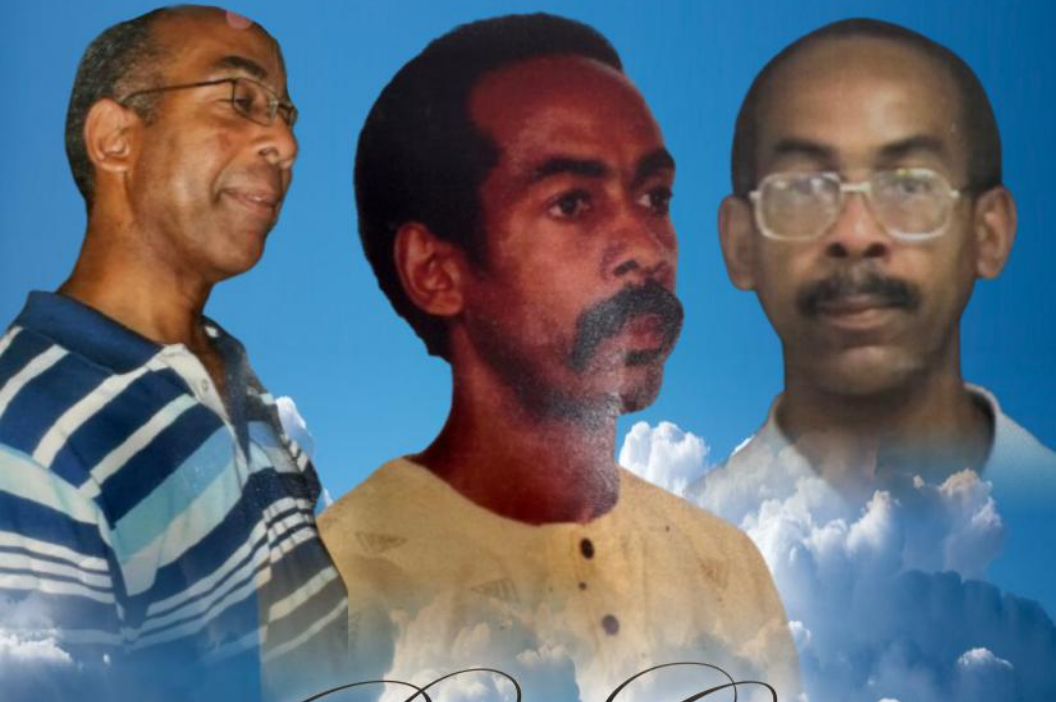

Obituary
